I want to encourage you to register to attend one or more of the outstanding in-person continuing education opportunities being held within the Mid-Atlantic Athletic Trainers' Association. North Carolina and Virginia have already held spectacular clinical symposiums this year.

The 2025 MAATA Clinical Symposium and Annual Meeting will be held in Virginia Beach at the Founders' Inn on May 2-4. I hope to see you in Virginia Beach! The MAATA leadership will provide updates at the MAATA Business Meeting on the morning of May 4. In addition to updates, the membership present at the business meeting will vote on some proposed changes to MAATA Constitutional and Bylaw. Here is a summary of the proposed changes to the MAATA Constitution & Bylaws:

- Changing the district secretary term of office to coincide with the NATA District Secretary and Treasurer terms of office
- 2. Changing the language in the documents to allow the annual business meeting to be held in person or virtually separate from the annual symposium
- Altering language in the documents to provide the District Director-Elect with a 14- month shadow period
- 4. Adding the Student Senate to the bylaws
- 5. Verbiage was changed to allow voting to be done in-person or electronically
- 6. Formalizing the role of the parliamentarian
- 7. Clarifying conflicting language regarding how committee chairs and members are elected and approved.
- 8. Correcting numbering or grammatical issues
- 9. Changing verbiage to minimize discrepancies and/or redundancies

The proposed changes will be sent out before April 1. Please take time to review the proposed changes before the MAATA Annual Business Meeting on May 4. <u>DCATA Ethics Committee:</u> Licensure by the DC Board of Health is required of all Athletics Trainers practicing in the District of Columbia. If you are not licensed, you can apply for licensure using <u>THIS LINK</u>. Per the DC Board of Health, "Athletic trainers who practice without a license (or with an expired license) will be subject to disciplinary action by the Board of Medicine and prosecution for unlicensed practice. Additionally, the Board may take action against any other licensed healthcare professional facilitating unlicensed practice."

You can direct any ethics-related questions to the Executive Committee or an Ethics Committee member.

February 25th, 2025 - South Carolina Athletic Training Day!!



Hit the Hill Day took place on February 25th, with 15 athletic trainers from across the state gathering in Columbia, SC. Representative Erickson, joined by Representative Neal Collins introduced SCATA members in the house balcony and proclaimed it was South Carolina Athletic Training Day!

In the South Carolina Senate, Senator Ott introduced SCATA members that were present in the balcony and discussed the importance of the profession. He also formally invited the SCATA to provide coverage of the annual legislative softball game that is held at the Columbia Fireflies stadium!

SCATA is supporting bill H3576, known as the Luke Barret Act which will increase AED access in public schools, and cardiac emergency response plans. SCATA members spoke with many legislators discussing AED access, athletic trainers in the secondary school setting, and increasing access to athletic trainers.

On Saturday, January 25th SCATA hosted high school students from all across the state for our Annual Secondary Schools Workshop at White Knoll High School. We had 175 students and 25 ATCs registered for the workshop – our largest registration ever! Unfortunately, due to the

snow in the Lowcountry many registrants were unable to attend. We were able to still have over 20 different high schools represented with 90 student attendees. We had 17 ATCs in attendance as well for CEU sessions in the morning and afternoon. We had 5 colleges represented and 1 business partner sharing about their program opportunities and leading hands-on sessions throughout the day. The student attendees had a great experience learning more about the skills of an athletic trainer and educational opportunities in the future. The workshop was a wonderful success!



VATA – VATA – Michael Kotelnicki EdS, ATC, LAT

The weekend of Jan 5th nearly 200 members and students attended the VATA annual meeting in Hampton Roads VA. The meeting had a focus on hands-on lab sessions, different work environments for athletic trainers, speakers presenting in a more interactive format and student attendance. This was the first year that the VATA gave each MSAT program in the Commonwealth four student registration vouchers to attend the meeting. In return, those students helped with the registration table and moderated educational sessions under the guidance of a certified athletic trainer. The weekend also included our awards and honors luncheon, an AT Olympics, Shenandoah University winning their third in a row state quiz bowl, annual past-president's breakfast, and an opportunity to network and socialize with friends, peers and students. It was a great weekend, well planned and organized by the annual meeting committee.

We want to thank some valuable members of our Executive Council as they move on or step down from their service to our state membership: Sara Spencer, Tom Campbell, Sara Pittelkau, John Goetschius, Anne Bryan and Jason Doctor.

We also are in the thick of our proposed heat legislation law at the state level with a unanimous 7-0 vote in favor while in sub-committee. The bill will emphasize guidelines and suggestions that are already in place but will mandate items such as cooling shaded area, water breaks, following wet bulb measurements and activities accommodations, water immersion device, and an emergency action plan. The Virginia department of education put this proposal in motion, as they sought our expertise to help with language and evidence-based protocols. We are hopeful that this bill will encourage schools in the secondary setting to look inward and be given the tools to help their athletes to avoid a heat related tragedy.

- a. HB 2172 Bill to add an AT to the WVBOPT, looking good on the house side, moving to the senate hopefully soon.
- SB 585 Bill to require soft-shell caps and develop advisory committee, working to make some amendments to add "licensed" athletic trainer as 2 positions on this committee
- c. We are extremely impressed with our new lobbying firm, Bowels Rice. We are also very grateful to Dr. Zach Garrett, Andrew Quinnlan and the governmental affairs committee for their work so far this legislative session.

Fundraising:

- a. The WVATA is excited to announce that we have fundraised approximately \$15,000 for the association. This is an incredible accomplishment made possible by Dr. Laura Wamsley and our fundraising task force.
