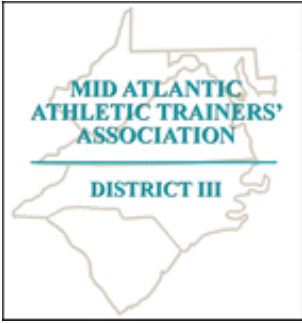


2013 DISTRICT COUNCIL MEETING

Absent from the Council but represented: Gregory Penczek (President of MATA)

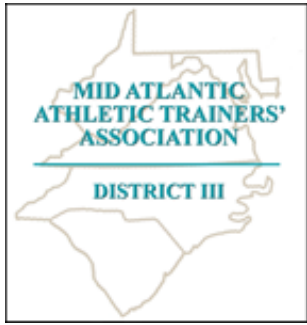
Absent from the Council: Drue Stapleton (President of WVATA)

1.0 Director Patricia Aronson:

- 1.1 Welcomed attendees to the District 3 Council Meeting and reviewed the current inhabitants of the current MAATA Executive Council. She also defined the District Council and added that we hope to add the President of the District of Columbia Athletic Training Association to this group.
- 1.2 Reviewed past discussion from the previous District Council Meeting
 - 1.2.1 NATA Legislative Grant Program Review: explanation of program provided and the timeline for application was discussed (opens July 1st and closes July 30th). The contact person for this program is Anna Sedory (Represents District 3 to Legislative Committee). Matching grants time period is August 1st till August 30th. Application were provided to the state presidents by Marty Baker with guidelines attached.
 - 1.2.2 Third-Party Payer Pilot: Marty Baker also provided the state presidents with a packet in Greenville, SC in May that explains the pilot program. Virginia is interest in participating in the program.
 - 1.2.3 Multi-web / Multi-view Advertising Program: Director Aronson shared additional information regarding the program the NATA uses which was gained from a presentation at the DST meeting 6/24/13. 30% of collective sales come to the District. DIII Secretary, Kevin King, will pursue this proposal. In addition, he will initiate and oversee the program. The group will be informed when the website will have a different look.

2.0 Treasurer Robert Cable: Bob's report consisted of a Balance Sheet as of May 30th, 2013 and a Profit and Loss handout as well as his explanation of the documents. The Balance Sheet will be posted on the MAATA.org website with the District Meeting Minutes.

- 2.1 Bob stated that we successfully passed the BOC Audit



- 2.2 Informed group that the membership needs to know that they must retain the back of the name badge since it possess CEU information for the MAATA symposium
- 2.3 District III has filed 2012 tax returns
- 2.4 Bob asked state presidents to notify him if their state is donating to the Foundation.
- 2.5 A discussion occurred amongst North and South Carolina regarding increasing state dues.
 - 2.5.1 The deadline to notify Kelly Carlin, of the NATA Membership, of changes is July 23rd
 - 2.5.2 North and South Carolina will provide updates of due changes before the July 23rd deadline

- 4.5 Director Aronson contributed with Jason Mitchell, the Program Coordinator, regarding consulting with the NATA regarding site selection

5.0 New District III NATA Committee Representatives Announced:

- 5.1 Ethics Committee: District III will be represented by Jatin Ambegaonkar from George Mason University
- 5.2 Ethnic Diversity Advisory Committee will be represented by Meghan Hammonds from Old Dominion University

6.0 Jennifer Rheeling (DC) Thanked the group for the support and updates the committee on its progress
